## Horse Riding Release Form (>18y/o)

I, , from here on known as RIDER, hereby verify that the following statements in this AGREEMENT are all true and factual to the best of my knowledge concerning:

- I, RIDER, have been informed of the inherent risks associated with riding, mounting, grooming, and boarding a horse. I, RIDER, release located at , from here on known as LESSOR, from all legal repercussions; I, RIDER, will not sue, defame, or charge LESSOR company or representatives for loss, damages, or injuries to myself, accompanying minors, or personal property (up to and including death).
- I, RIDER, understand that no horse is completely safe. If a horse is frightened or irritated, it may divert from any training it has received and act according to its natural survival instincts which may include but are not limited to: stopping short, changing directions or speed at will, shifting its weight, bucking, rearing, kicking, biting, running into or under obstacles, or running from perceived danger.
- I, RIDER, understand that LESSOR staff and/or representatives are not responsible for total or partial acts, occurrences, or elements of nature that can scare a horse, cause it to fall, or react in some other unsafe way. Some examples are: thunder, lightning, rain, wind, wild and domestic animals, insects, reptiles, which may walk, run, fly near, or bite or sting a horse or person; and irregular or obstructed footing on groomed or wild land (including indoor or outdoor arenas, pens, pastures or driveways) which is subject to constant change in condition according to use, weather, temperature, maintenance, and natural and man-made changes in landscape. Further still, LESSOR staff and/or representatives are not responsible for activities engaged in by others that may scare a horse. The rider and parent or legal guardian have inspected the premises and equipment used by LESSOR, and are satisfied that all premise and equipment conditions are reasonably safe for the riders's intended purpose, usage and presence.
- I, RIDER, understand that should emergency medical or other treatment be required, I understand that I, and/or my own accident/medical insurance company shall pay for all incurred expenses. I shall also pay any medical insurance deductibles.
- I, RIDER, understand that no horse is completely safe. If a horse is frightened or irritated, it may divert from any training it has received and act according to its natural survival instincts which may include but are not limited to: stopping short, changing directions or speed at will, shifting its weight, bucking, rearing, kicking, biting, running into or under obstacles, or running from perceived danger.
- I, RIDER, understand that, notwithstanding the presence or participation of an instructor or trainer, upon mounting a horse and taking up the reins, I, RIDER is in primary control of the horse. My safety largely depends upon his/her ability to carry out simple instructions, and his/her ability to remain balanced aboard the moving animal. I, RIDER shall be responsible for his/her own safety and that of an unborn child if the RIDER is pregnant. Pregnant women should ride horses only under the advice of their physician. LESSOR staff and/or representatives have advised me, RIDER, that pregnant women should not ride horses.
- I, RIDER, confirm that the I do not have epilepsy or a heart condition, is not currently pregnant, and that is not recovering from any major procedures or operations.
- I, RIDER, understand that equipment, including bridles, saddles, and reins, can break or malfunction at any time, causing injury or death. I have been offered the use of protective headgear while present at .
- I understand that this document is equal to the entire agreement between the parties. This lease may not be modified or amended in any manner except by an instrument in writing executed by the parties.
- I confirm that I, RIDER, understand that this document is being provided to me by Pegasus App LLC for my convenience and in no way involves, includes or infers inclusion of the Pegasus App LLC in any actions, events or activated related to this AGREEMENT.
- I confirm that I, RIDER, agree that in the event that a civil, criminal or common law suit arises from

actions, activities, misunderstandings or events, pertaining to this AGREEMENT, I indemnify Pegasus App LLC of any and all liability and/or involvement in the law suit, including prosecution in said law suit.

- This Agreement shall be governed by the laws of the State of , provided however, the parties agree to required Mediation and Arbitration of any disputes relating to this transaction. Any legal action commenced to enforce or interpret this Agreement shall be brought in state or federal courts with the appropriate jurisdiction, located in (City) (State), (Country).
